RE: "Special Investigations Agency" Website

Dear Mr. LaChapelle:

We represent Mr. Jim Morrisett and Alpine Petroleum, LLC. We hereby demand that you remove certain libelous publications concerning Mr. Morrisett and Alpine Petroleum from the "Special Investigations Agency" website. The publications, described with specificity below, impugn Mr. Morrisett and Alpine's reputations and business, falsely accusing each of them of dishonesty and illegal activity. These publications are libelous *per se*. If they are not removed from the SIA web-pages by **Monday, October 16, 2006 at 5:00 p.m. PST**, Mr. Morrisett and Alpine will be prepared to seek an appropriate remedy in a court of competent jurisdiction. SIA, and any others who may be responsible for these publications, will be held accountable for the noted offending publications.

The Libelous Publications

(1) "ENERGY 2000 - ALPINE ENERGY - JIM MORRISETT Continue to Scam Investors" published at URL: <http://www.us-sia.org/2006/06/energy-2000-alpine-energy-jim.html>

This statement is false and clearly defamatory. This particular SIA web page is entitled "S.I.A. Investigative News" and contains two postings by purportedly anonymous individuals. Those two postings relate to Energy 2000, a company from which Mr. Morrisett resigned in November 2004. Mr. Morrisett has had no association with Energy 2000 since November 2004. Additionally, Alpine is not a successor to Energy 2000 and has never had any association with Energy 2000.

Further, there is no information in either of the two "anonymous" postings which might corroborate the assertions that Alpine or Mr. Morrisett "Continue to Scam Investors." Thus, not only

is the title of the page false, it is entirely unsupported by the specified allegations which you have republished, and continue to republish.

We demand that this title be removed from all SIA related web-pages. This includes, but is not limited to, the following URLs:

(2) "SIA has launched an investigation into a group of individuals that have bilked investors for large amounts of money . . . The individuals are: Rick Dickerson and Jim Morrisett." Located at URL: <http://us-sia.org/cases/currentCases.html>

Judging by the hyperlink provided, the basis for this statement is the SIA "case" summary concerning Energy 2000 (found on your website here: <http://www.us-sia.org/cases/energy2000.htm>). That summary discusses a January 2004 transaction between Energy 2000 and Wallstin Petroleum. Although Mr. Morrisett was an employee of Energy 2000 in January 2004, he had no direct involvement in the Wallstin-Energy 2000 transaction. The statement that Mr. Morrisett has "bilked investors" is false and, again, is not supported by the information which you have chosen to include in your "case" summary. Wallstin entered an agreement with Energy 2000 for an interest in certain wells, not with Mr. Morrisett or Alpine. It is our understanding that Wallstin has filed a lawsuit in Texas based upon its allegations, republished by you on your website. Mr. Morrisett was not named as a defendant in that action.

(3) The references to Mr. Morrisett in the "Energy 2000, Inc." case summary. Located at URL: <http://www.us-sia.org/cases/energy2000.htm>


This case summary deals primarily with allegations of wrongdoing by Energy 2000 and Rick Dickerson. At the end of that summary, it is alleged that Mr. Morrisett orchestrated a transaction between B&B Oil, Inc. and Red Earth Resources. It is further alleged that Mr. Morrisett promised to pay a certain sum to Wallstin from the proceeds of this transaction. These allegations are categorically denied.

The references to Mr. Morrisett involve false attributions of dishonesty, are libelous *per se*, and must be removed within the noted timeframe.
